2. Capital and Collaborative Initiative Presentation

Carmen Panacopoulos presented on the Federal Reserve Bank of Boston's Capital and Collaborative Initiative (see here). It grew out of the Working Cities Challenge, which is in its 3rd year. C&C was launched in July 2015 to complement Working Cities Challenge without detracting from the leadership being developed. It is being done in partnership with Kresge Foundation. They see 3 types of projects lacking, Mixed Use \$ Community Development, Small Business Development, and Scattered Site or Small Residential Development. The final report is about to be released.

For small business projects, the focus is on identifying and providing culturally appropriate resources and working with the SBA on culturally tailored events in each partner city. They

will also be working on a statewide conference to coordinate efforts. Carmen also noted that the Working Cities challenge has expanded to Rhode Island and Connecticut. Her presentation can be found here and an article on the initiative can be found here.
